The meeting was opened with Salute to the Flag led by Supervisor Todd Bradt.

Ivan Duesler made a motion to accept the minutes from November 9, 2011 Regular meeting. 2nd by George Cosselman. 4 Ayes. Carried.

George Cosselman made a motion to pay General bills, Abstract 12, Claim # 202 thru 221 for the amount of \$ 8,784.21. 2nd by Ivan Duesler. 4 Ayes. Carried.

Ivan Duesler made a motion to pay Highway bills, Abstract 12, Claim # 265 thru 286 for the amount of \$ 13,553.06. 2nd by Andy Chorlton. 4 Ayes. Carried.
