Jim Mraz presented an overview for the needed steps to take for a Comprehensive Plan:

- 1. Town to decide if a Comprehensive Plan should be developed
- 2. Decide who should develop the plan
 - The Town Board
 - The Planning Board
 - A Special Board
- 3. Decide size and composition of the committee
- 4. Decide what zoning to put in place

The APA would need to approve final plans also.

The Planning Board made the following recommendations:

- 1. Amend Site Plan Review to include new technology: telecommunication towers & control stations; land lease requests, easements, & right-of-way
- 2. Town of Ephratah begin the development of a Comprehensive Plan
- 3. A web site for residents input of opinion

Highway Superintendent: Back yard is cleaned and metal taken to scrap yard. Check received. First Aide/CPR completed. M Shaw Training will take place 5/21/2012. The new truck will be ready around the end of May. Jim asked the Board for permission to put out for bid truck #3.
