Ivan Duesler made a motion to accept the minutes from August 8, 2012 Regular meeting. 2nd by Andy Chorlton. 4 Ayes. Carried.

Andy Chorlton made a motion to pay General bills, Abstract 9, Claim # 114 thru 130 for the amount of \$ 6,016.23. 2nd by Ivan Duesler. 4 Ayes. Carried.

Thomas Miles made a motion to pay Highway bills, Abstract 9, Claim # 141 thru 157 for the amount of \$ 190,272.66. 2nd by Ivan Duesler. 4 Ayes. Carried.

Resolution 77

Thomas Miles offered Resolution 77 to accept Sara Gray as a board member on the Recreation Commission, to fill a vacant position. 2nd by Ivan Duesler. 4 Ayes. Carried.

Resolution 78

Thomas Miles offered Resolution 78 to appoint 2 Town Board Members to the Comprehensive Planning Committee. The Members will be: Todd Bradt and Ivan Duesler. 2nd by Andy Chorlton. 4 Ayes. Carried.

A date needs to be set for the Comprehensive Planning Committee to meet. Todd Bradt will contact Jim Mraz to schedule a date and time convient for the members and Mr. Mraz.

Resolution 79

Ivan Duesler offered Resolution to accept the members from the Planning Board, Judy Townsend and Nancy Christman, with Rose Woolley as alternate. 2nd by Thomas Miles. 4 Ayes. Carried.

Resolution 80

Thomas Miles offered Resolution 80 to close the Public Hearing on the RGL Fire contract. 2nd by Andy Chorlton. 4 Ayes. Carried.

Resolution 81

Thomas Miles offered Resolution 81 authorizing Supervisor Todd Bradt to enter into a Three (3) year contract with the Rockwood-Garoga-Lassellsville (RGL) Fire Department. The payment schedule is to be as follows:

- Year One (2013) \$63,000 (Increase of \$1,000)
- Year Two (2014) \$64,000 (Increase of \$1,000)
- Year Three (2015) \$65,000 (Increase of \$1,000)

2nd by Ivan Duesler. 4 Ayes. Carried.

Resolution 82

Andy Chorlton offered Resolution 82 authorizing Supervisor Bradt to enter into a contract with Greg Fairchild, Gloversville, to mow 12 Town Cemeteries, 4 times a year. These cemeteries must be mowed before the major holidays, (Memorial Day, July 4th, Labor Day and one time in between when needed). Total for mowing is to be \$451.25. Gas Surcharge is added for the amount of \$40.50. Total is \$491.75. 2nd by Ivan Duesler. 4 Ayes. Carried.

Budget Workshop date is set for September 26, 2012 at 7 PM at the Town Hall.

Clerk Eleanor Smith requested the Town Board to pass a resolution that the Ephratah Rural Cemetery may store their records in a fire-proof safe, bought by the Cemetery, at the Town Hall. Prior, Supervisor Bradt, Attorney Albanese, and the Mang Insurance Co. saw no problem with storing the records at the Town Hall. Jim Berry *temporarily* put a hold on this agreement by calling a "Special Consultant" at the Association of Towns' Office, misinforming the consultant regarding the facts about the cemetery, even though a law had been passed in 2010 by NYS Governor, allowing municipalities to provide goods and/or services to public cemeteries.

Ephratah Rural Cemetery is an independent, not-for-profit cemetery, not a private cemetery, as Jim Berry led the consultant to believe.

Resolution 83

Thomas Miles offered Resolution 83 authorizing Ephratah Rural Cemetery and Rockwood Cemetery to store the records in their safes at the Town Hall. 2nd by Andy Chorlton. 4 Ayes. Carried.

Unfinished Business: None

Phone calls have been received from a few residents regarding animals in the middle of the road on County Hwy 119.

Mike Albanese will check into the law regarding animals running loose, then a certified letter can be sent to the animal owners if need be.
