### **Resolution 75**

### **Resolution 76**

Ivan Duesler offered Resolution 76 to move the Tentative budget 2014 to Preliminary budget 2014. 2<sup>nd</sup> by Thomas Miles. 5 Ayes. Carried.

### **Resolution 77**

Andy Chorlton offered Resolution 77 to schedule a Public Hearing for the 2014 Preliminary Budget on November 13, 2013 at 6:15 p.m. at the Ephratah Town Hall and to be advertised in the Legal section of the Leader Herald. 2<sup>nd</sup> by Ivan Duesler. 5 Ayes. Carried.

Carolyn Honeywell asked if zoning was talked about under the Comprehensive Plan.

### **Resolution 78**

Ivan Duesler offered Resolution 78 to override the 2% tax cap regarding the budget. The County added \$7,485 to the Town of Ephratah for Workers' Compensation, causing the town to go over the tax cap.  $2^{nd}$  by George Cosselman. 5 Ayes. Carried.

George Cosselman made a motion to officially claim October 31, 2013 for trick or treat from 6p.m. to 8 p.m. for Halloween. 2<sup>nd</sup> by Thomas Miles. 5 Ayes. Carried.

Lyn Smolik stated she didn't want to see a National Chain come in to the town when the town already has a diner/store established. Could a gas station be competitive and not charge an outrageous price for gas?

Neil Cronin commented on the Comprehensive Plan and when does the zoning come in to play?

Ivan Duesler made a motion to close the Comprehensive Plan Public Hearing, since there was no one else to speak.  $2^{nd}$  by Thomas Miles. 5 Ayes. Carried. Time: 6:50 p.m.

#### **Resolution 79**

Town Board Member Ivan Duesler introduced the following Resolution and moved its adoption:

#### RESOLUTION DESIGNATING THE TOWN OF EPHRATAH TOWN BOARD AS SEQR LEAD AGENCY AND TO ISSUE A NEGATIVE DECLARATION REGARDING THE ADOPTION OF A NEW COMPREHENSIVE PLAN FOR THE TOWN OF EPHRATAH

WHEREAS, the Town of Ephratah Comprehensive Plan Committee has submitted a proposed new Comprehensive Plan to the Town Board, and

WHEREAS, the Town of Ephratah Town Board has completed a Part 1 Environmental Assessment Form (EAF), and

WHEREAS, the EAF identified the Involved Agencies for this proposed action to be:

- Town of Ephratah Town Board
- NYSDEC
- Adirondack Park Agency

WHEREAS, the Town Board has classified the proposed adoption of a new Town of Ephratah

Comprehensive Plan as a Type 1 Action, and

WHEREAS, the Town Board has proposed itself as the Lead Agency for the purposes of conducting a Coordinated SEQR review of the proposed project, and

WHEREAS, the Town has sent copies of the Part 1 EAF and Draft Comprehensive Plan to all Involved Agencies informing them of the Town Board's desire to serve as the Lead Agency and asked all Involved Agencies to submit comments back to the Town by 5:00 p.m. on Tuesday, October 8, 2013 on whether they consent to the Town board serving as Lead Agency and whether the Involved Agencies have any comments on whether the proposed action may create any significant impacts on the environment, and

WHEREAS, the Town has received written responses from both the APA and the NYS Department of Environmental Conservation advising that they consent to the Town Board serving as Lead Agency, and

WHEREAS, the Town Board has completed and reviewed Part 2 of the EAF,

NOW, THEREFORE BE IT

RESOLVED, that the Town Board hereby designates itself as Lead Agency for the purposes of conducting a coordinated review of the proposed action, and be it further

RESOLVED, that after reviewing the Part I and II of the EAF, input received from Involved Agencies and public input, the Town Board has determined that the adoption of the proposed Comprehensive Plan will not create any significant environmental impacts, and be it further

RESOLVED, that the Town Board hereby issues a Negative Declaration and authorizes the Negative Declaration be filed in accordance with the SEQR Regulation, and be it further

RESOLVED, that certified copies of this resolution be forwarded to the Town Supervisor, Town Clerk, Town Attorney, Town Code Enforcement Office, APA and the NYS Department of Environmental Conservation.

Town Board Member Thomas Miles seconded the motion.
