Reports:

Code Enforcement Officer:

• Code Enforcer, Devon Percival reported that the Dollar Store building was running approximately 6 weeks behind schedule. The NYS DOT would like the Dollar Store to put up signs because of the materials being delivered.

• Mr. Percival said that there is a property on Rte 67 that would not be a buildable property because it has a shared well. He mentioned a few other projects going on in the town such as: a resident is building on Rte 10 in the same footprint, there is also a deck being added to a home on Fical Road. Also on Fical Rd, another resident is putting up a storage shed. There is also a house is going in on Kringsbush Rd.

• Mr. Percival also noted that Heidelberg does not have a blasting permit/mining permit; but they can still sell aggregate out of there.

• Bedrock Solar said they were still planning to develop a solar site on Rte 29. Mr. Percival said they will have permit fees due.

• The Brookside Tavern is waiting on an approval from the Department of Health regarding the septic system.
